

JUDICIAL POWER OF THE STATE OF CHIHUAHUA.
CERTIFIED COPY OF DIVORCE DECREE.

THE HONORABLE RODOLFO SILVA, CLERK OF THE FIRST CIVIL COURT OF THE BRAVOS DISTRICT, STATE OF CHIHUAHUA, REPUBLIC OF MEXICO, -

C E R T I F I E S:- That in the Suit for Necessary Divorce instituted by Mrs. MARJORIE J. FREED against Mr. ALAN FREED, a judgment was pronounced as follows:- - - - -

J U D G M E N T:- Ciudad Juarez, Chihuahua, July 25th twenty-fifth, 1958 nineteen hundred and fifty-eight.- Having -- brought for final decision the suit for necessary Divorce-instituted by Mrs. MARJORIE J. FREED against Mr. ALAN FREED (File No. 2297/958); and W H E R E A S:- By petition dated today in this City, Mrs. MARJORIE J. FREED submitting herself expressly to the jurisdiction and competence of this-Court, instituted suit for Necessary Divorce against her - husband Mr. ALAN FREED, claiming as grounds the incompati-bility of temperaments existing between them, and stating: That the marriage was contracted August twelfth, nineteen hundred and fifty, at the City of Toledo, State of Ohio, United States of America, as proven by the testimonial - information offered; that the issue from this marriage are two minor children named: SIEGLINDE FREED and ALAN FREED JR., who are residing abroad under the custody and guard-ianship of the mother, and they shall continue that way in the future; that there is no community property from - this marriage, as those they acquired have already been - divided accordingly between her husband and herself as - per Separation Agreement entered into on July eighteenth, nineteen hundred and fifty-eight, at New York City, Sta-te of New York, United States of America, and which must be incorporated by reference into this decree, same as - if it were recited in full in order that it survives and be in full force and legal effect after the final judg-ment without merging it with same.- THE PETITION WAS EN-TERED, ordering that the testimonial information be re-ceived, to notify the Public Attorney, and to serve the defendant a ccordinly, and as the plaintiff Mrs. MARJORIE

J. FREED appeared personally before the undersigned Judge to file her petition, she was notified of the order given and said: That she ratifies the petition in all its parts, including that part - which refers to her express submission to the jurisdiction and - competence of this Court, and presented besides a residence certificate issued to her by the City Hall of this City, with which she proved to be legally registered in the Official Book of residents of this City; and by pleading dated this same day, Licenciado Jorge Mena Baca, as Lawful Attorney-in-Fact for the defendant Mr. ALAN FREED, answered in his name the petition filed against him, confessing same in all its parts, stating that he submits him expressly to the jurisdiction and competence of this Court, and requesting - the judgment which is today pronounced, in view of the fact that - all the legal requirements have been complied with, including the - payment of the publication of this decree by receipt No. 159919, - issued this same day, by the State Tax Collector of this City; and

W H E R E A S:- This Court is competent to resolve in definite the present suit, according to articles 22 and 24 of the Divorce Law, - as the plaintiff proved to be legally registered in the Official - Book of residents of this City at the time of filing her petition, according to article 23 of the same Law, as both parties submitted expressly to the jurisdiction and competence of this Court; the testimonial information was rendered, according to article 29 of the - same Law, to prove the existence of the marriage of the parties, - and the birth of the minor children.- As grounds for the divorce - the plaintiff claimed the incompatibility of temperaments, grounds provided for in Section XIX of article 3rd of the Divorce Law, and by confessing the petition in all its parts, said ground was plainly proven according to article 370 of the Civil Code of Legal Procedure, applied supplementary.- Having stated in the petition that there is no community property from this marriage, nothing will be declared in this decree to this respect, and in regards to the minor children of this marriage, according to article 14 of the Divorce Law, and considering the opinion of the Public Attorney, said minor children shall remain under the same condition as they now are.- Therefore, based also on articles 1, 2, 10, 37, 43, 44 and 45 of the Divorce Law mentioned, it is definitely decreed:- FIRST:- It is de-

clared dissolved with all its legal consequences, the marriage -
 contracted by ALAN FREED and MARJORIE J. FREED, on August twelfth,
 nineteen hundred and fifty at the City of Toledo, State of Ohio, -
 United States of America, leaving both parties legally free and in
 aptitude to contract new marriage.- SECOND:- It is declared that -
 the two minor children of said marriage, named SIEGLINDE FREED and
 ALAN FREED JR., will remain under the custody and guardianship of-
 the mother.- THIRD:- It is approved in all its parts, the Separation
 Agreement entered into by the parties on JULY eighteenth, -
 nineteen hundred and fifty-eight, at New York City, State of New -
 York, United States of America, and which has been incorporated by
 reference into this decree, same as if it were recited in full in -
 order that it survives and be in full force and legal effect after -
 the final judgment without merging it with same.- FOURTH:- Regis-
 ter the present judgment, publish same, give the interested parties
 the certified copies requested and in due time file the records.- -
 It was definitely decreed and signed by Licenciado Ignacio Martinez
 Aguayo, Judge of the First Civil Court of the Bravos District.- At-

 and MARJORIE J. FREED, it is now declared final and definitely exe-
