Alan Freed is 38 years old. He comes from Ohio, where he graduated from Ohio State University majoring in Mechanical Engineering. He has been married three times and has four children. His present wife is his former secretary, Inga Boling Freed, who formerly lived at 95 West 162nd Street, New York 52, New York.

His previous wives were Jacqueline and Marjorie J.

Freed lived with his wife Inga at 2 Fifth Avenue in Penthouse Apartment H., which he had subleased from Arthur H. Borinstein who is employed by Dreyfus & Co. at 2 Broadway. Freed agreed to sublease this apartment from November 1, 1958 until September 30, 1960 at a monthly rental of \$375.00 a month. He moved out without notice on April 15, 1960. Mr. Borinstein advised the writer that Freed owes him five months rent for the remainder of the term of the lease and that he intends to sue him for that balance which amounts to \$1875.00.

Mr. Borinstein states that he never saw Freed and that the checks for the rent were always signed by Inga Boling. When Freed moved from the apartment, he left it in terrible condition.

Alan Freed rented a home at 82 Sea Beach Drive, Stamford, Conn. from May until October, 1955, at which time he purchased the home "Graycliff" at Wallacks Drive, Stamford, Conn. for a total of \$46,820. A local bank holds a mortgage of \$25,000 on this home.

In 1956, Freed maintained a satisfactory personal checking account with the Security Bank and Trust Company of Stamford, Connecticut where his average balance was low to middle four figures.

Diners Club 10 Columbus Circle New York, New York Mrs. A. Benson, supervisor of the Credit Department advised the writer that Alan Freed had a personal credit card with the Diners Club, which was applied for on November 20, 1956. He owes them about \$900.00. A photostatic copy of his application together with a bank reference is herewith attached.

Saks Fifth Avenue 5th Avenue & 49th St. New York, New York The writer interviews Mr. Blum, Manager of the Credit Department and was advised that Alan Freed has had a charge account with them since March of 1955. He stated that Freed owes them about \$3000 and that they are preparing to refer

the account to their legal department. Attached is a photostatic copy of the application for the charge account.

Bloomingdales New York, New York

According to Miss DeOuise of 59th St. & Lexington Ave. the Credit Department located at 155 E. 60th Street, the original charge account was opened by Freed's wife Marjorie on June 10, 1955. Inga Boling also had a charge account there which was opened up on July 18. 1956. Inga Boling's account was changed to Mrs. Alan Freed on January 5, 1960. Freed owes this account \$316.06. A photostatic copy of the application is herewith attached.

Bergdorf Goodman Co. 754 5th Avenue New York, N. Y.

The writer spoke to Mr. Shimer of the Credit Department who stated that Mrs. Jacqueline Freed had opened the account there on September 10, 1956. There is \$41.00 owed on the account. A photostatic copy of the application is attached.

Lord & Taylor 5th Avenue & 38th St. New York, New York

According to Mrs. Eleanore Bookmeyer of the Credit Department this charge account was opened on December 1, 1955 by Mrs. Jacqueline Freed. The account is paid up and has not been used since April 1959. There was a high credit on this account over a three month period of \$10.770. Attached hereto is a photostatic copy of the application.

The writer went to Radio Station W.A.B.C. at 7 West 66th Street and spoke to Mr. DeBare of the legal department. Mr. DeBare advised the writer that all contracts and financial data on Alan Freed have been turned over to A.D.A. Stone and are still in his possession. The writer interviewed Mr. J. J. Madden of W.N.E.W.-T.V. at 205 East 67th Street. He stated that Alan Freed had worked for them from June 30, 1958 to December 6, 1959. Mr. Madden stated that they had no direct contract with Alan Freed but that their contract was with Stamford Productions of Wallacks Point, Stamford, Conn.

The station paid Stamford Productions \$450 a week and they, in turn, paid Freed.

At station W.I.N.S. the writer spoke to Mr. Soupios, the Treasurer. He stated that all the data on Alan Freed is in the possession A.D.A. Stone. He stated that Freed worked for them from 1954 to March, 1958. During that time Freed received a total of \$70,679.95 partially from station W.I.N.S. and partially from the Gotham-Freed Co.

According to information, Freed is at present living at 309 Desert-Holly Circle, Palm Springs, California and will shortly appear on Radio Station K.D.A.Y. in Los Angeles, California.
